

CAMPS AND EXCURSIONS POLICY

RATIONALE:

Participating in excursions, incursions and Outdoor Education (camping) is seen as an integral part of the curriculum as it enable students to explore, extend and enrich their learning and their social skills development, in a non-school setting. Excursions, incursions and camps complement, and are an important aspect of the educational programs offered at the school. Camps may have an environmental or outdoor emphasis and are a vital component of the educational programs offered at Amsleigh Park Primary School.

GOAL:

To explain to our school community the processes and procedures Amsleigh Park Primary School will use when planning and conducting camps, excursions and adventure activities for students.

Scope

This policy applies to all camps and excursions organised by Amsleigh Park Primary School. This policy also applies to adventure activities organised by Amsleigh Park Primary School, regardless of whether or not they take place on or off school grounds, and applies to school sleepovers.

This policy is intended to complement the Department's policy and guidelines on excursions, camps and adventure activities which all Victorian government schools are required to follow. Amsleigh Park Primary School will follow both this policy, as well as the Department's policy and guidelines when planning for and conducting camps and excursions.

Definitions

Excursions:

For the purpose of this policy, excursions are activities organised by the school where the students:

- are taken out of the school grounds (for example, a camp, day excursion, school sports);
- undertake adventure activities, regardless of whether or not they occur outside the school grounds;
- Attend school 'sleepovers' on school grounds

Camps are excursions involving at least one night's accommodation (including school sleepovers).

Local excursions are excursions to locations within walking distance of the school and do not involve 'Adventure Activities'.

Adventure activities are activities that involve a greater than normal risk. Further information and examples of adventure activities are available on the Department's website under Adventure Activities, at the following link:

GUIDELINES:

- ❖ Camps and excursions can provide a valuable educational experience for our students which are complementary to their school based learning, as they provide access to resources, environments and expertise that may not be available in the classroom. Participation in the 'optional' Outdoor Education program enables students to explore, extend and enrich their learning and social skills development, in a non-school setting.
- ❖ For all camps and excursions, including adventure activities, our school will follow the Department's Policy and Advisory Library: [Excursions](#).

Planning process for camps and excursions

- ❖ All camps and excursions will comply with Department planning requirements.
- ❖ Part of this planning process includes conducting risk assessments, to ensure that reasonable steps are taken to minimise the risks associated with each proposed camp or excursion. Amsleigh Park Primary School's risk assessment will include consideration of arrangements for supervision of students and consideration of the risk of bushfire activity in the excursion location. In the event of a Code Red Day being announced, excursions or camp activities in effected locations will be cancelled or rescheduled. Planning will also cover arrangements for cancelling, recalling or altering the camp or excursion for any other reason.
- ❖ Amsleigh Park Primary School is committed to ensuring students with additional needs are provided with an inclusive camps and excursions program and will work with families during the planning stage, as needed, to support all students' attendance and participation in camp and excursion activities.
- ❖ In cases where a camp or excursion involves a particular class or year level group, the Organising Teacher will ensure that there is an alternative educational program available and appropriate supervision for those students not attending the camp or excursion.

Supervision

- ❖ Amsleigh Park Primary School follows the Department's guidelines in relation to supervision of students during excursions and camps.
- ❖ All excursion staff (including parent volunteers) will be familiar with supervision requirements and the specific procedures for dealing with emergencies on each camp and excursion.
- ❖ All school staff will be aware that they retain overall responsibility for the supervision and care of students throughout all camps and excursions (including adventure activities), regardless of whether or not external providers are managing the activity.

Parent volunteers

- ❖ Parents may be invited to assist with camps and excursions. School staff will notify parents/carers of any costs associated with attending. School staff are in charge of camps and excursions and parent/carer volunteers are expected to follow teachers' instructions. When deciding which parents/carers will attend, the Principal and Organising Teacher will take into account: any valuable skills the parents/carers have to offer (e.g. bus licence, first aid etc.) and the special needs of particular students. All parents/carers/volunteers that attend camps or excursions, must abide by the Amsleigh Park Child Safe Code of Conduct Policy, to ensure we provide a Child Safe Environment on camps and excursion. Parents/carers/volunteers will be briefed on these expectations prior to the commencement of camp.

Volunteer and external provider checks

- ❖ Amsleigh Park Primary School requires all parent or carer camp or excursion volunteers and all external providers working directly with our students to have a current Working with Children Check card. Parent/carer consent

- ❖ For all camps and excursions, Amsleigh Park Primary School will provide parents/carers with a specific consent form outlining the details of the proposed activity. Amsleigh Park Primary School informs parents about school camps and excursions using XUNO asking parents/carers to provide a digital signature confirming they consent to their child's participation. (2 Step process) Parents/carers are encouraged to contact the school to discuss any questions or concerns that they or their child may have with a proposed camp or excursion.

Parent Payments for camps and excursions

- ❖ Most camps and excursions provided by Amsleigh Park Primary School enhance and broaden the schooling experience of our students but are not a mandatory component of our curriculum. These activities are provided on a user-pays basis in accordance with the Department's Parent Payments Policy.
- ❖ Consent forms will have clearly stated payment amounts and finalisations dates, and families will be given sufficient time to make payments.
- ❖ Students who have not finalised payment by the required date for camps and excursions provided on a user pays basis will not be able to attend unless the Principal determines exceptional circumstances apply.

Financial Help for Families

- ❖ Amsleigh Park Primary School will make all efforts to ensure that students are not excluded for financial reasons. Families experiencing financial difficulty are invited to discuss alternative payment arrangements with the Business Manager or Principal. The Business Manager can also discuss family eligibility for the Department's Camps, Sports and Excursions Fund (CSEF), which provides payments for eligible students to attend school activities, including camps and excursions. Applications for the CSEF are open to families holding a valid means-tested concession card or temporary foster parents and are facilitated by the school. Refunds

- ❖ If a camp or excursion is cancelled or altered by the school, or a student is no longer able to attend part or all of the camp or excursion, our school will consider requests for partial or full refunds of payments made by parents/carers on a case-by-case basis taking into account the individual circumstances. Generally we will not be able to refund payments made for costs that have already been paid where those funds have already been transferred or committed to a third party and no refund is available to the school. Where possible, we will provide information about refunds to parents/carers at the time of payment.

Student health

- ❖ Parents and carers need to ensure the school has up-to-date student health information prior to camps and excursions. A member of staff will be appointed with responsibility for the health needs of the students for each camp/excursion. Teachers will administer any medication provided according to our *Medication* policy and the student's signed *Medication Authority Form*. To meet the school's obligations relating to safety, a first aid kit and mobile phone will be taken by teachers on all camps and excursions.
- ❖ It is the responsibility of parents and carers to ensure their child/children are in good health when attending excursions and camps. If a student becomes ill during a camp and is not able to continue

at camp it is the parent/carer's responsibility to collect them and cover any associated costs. If the Principal approves a student joining a camp late, transport to the camp is the parent/carer's responsibility.

Behaviour expectations

- ❖ Students participating in camps and excursions are required to cooperate and display appropriate behaviour to ensure the camp or excursion is a safe, positive and educational experience for all students involved.
- ❖ Parents/carers will be notified if their child is in danger of losing the privilege to participate in an excursion or camp due to behaviour that does not meet the standards of behaviour set out in the school's *Student Wellbeing and Engagement Policy*. The decision to exclude a student will be made by the Principal or Assistant Principal, in consultation with the Organising Teacher. Both the parent/carer and the student will be informed of this decision prior to the camp or excursion.
- ❖ If on a camp or excursion the Teacher in Charge considers an individual student's behaviour does not meet required standards, then the Principal or their nominee may determine that a student should return home during the camp or excursion. In these circumstances the parent/carer is responsible for the collection of the student and any costs associated with this.
- ❖ Disciplinary measures apply to students on camps and excursions consistent with our school's *Student Wellbeing and Engagement Policy* and *Bullying Prevention Policy*, in line with the School Wide Positive Behaviour Support philosophy.

Electronic Devices

- ❖ Students will not be permitted to bring electronic devices to camps or excursions except with prior approval from the Principal. The Principal will only approve students bringing electronic devices to a camp or excursion in exceptional circumstances and when it is in the best interests of the student, and may place conditions on its location and use during the camp or excursion.

Food

- ❖ Students are not permitted to bring their own supply of food items to camps and excursions unless the item is medically indicated and discussed with the Organising Teacher, or included as an item on the clothing and equipment list for that camp or excursion.

Accident and Ambulance Cover

- ❖ Any costs associated with student injury rest with parents/carers unless the Department is liable in negligence (liability is not automatic).
- ❖ Unless otherwise indicated, Amsleigh Park Primary School and the Department do not provide student accident or ambulance cover. Parents/carers may wish to obtain student accident insurance cover and/or ambulance cover, depending on their health insurance arrangements and any other personal considerations.
